The garnishment deduction of 25% would create a hardship for me and my family; however, in lieu of a hearing, I agree to have the plaintiff reduce the garnishment deduction to the statutory minimum of 15% in their Order for Continuing Lien. Upon Plaintiff filing an Order for Continuing Lien reducing the garnishment deduction to 15%, I would like the court to please vacate any scheduled hearings. *NOTE: the judgment debtor is to call the Plaintiff's attorney to arrange the 15% reduction **prior** to requesting the hearing with the court.*
